



1. Terms and conditions for the WINLPG Bursary for LPG Residential Installation Course competition

1. **The promoter is:** The Liquefied Petroleum Gas Association of South Africa (LPGSA) (company no 1995/005678/08) whose registered office is at 4 Kya Sand Rd, Kya Sand, Randburg, 2163

6. All shortlisted applicants will be interviewed, virtually prior to final selection.
